Organization Overview

The Organization of Israel's Terror Victims represents thousands of terror victims and victims' families : widows and widowers , orphans, bereaved parents and disabled victims that have been recognized by the State of Israel as victims of hostile acts. The chairman, committee and members running the organization are mainly volunteers, who offer their time and effort to the organization without any r- compensation. All the members of the committee are victims of terror . From the very first day it was founded, the organization has treated thousands of victims of terror attacks.

During the year 1998, the organization was declared by the State of Israel, The Israeli Parliament (Knesset), and the Minister of Labor, as the official representative of the victims of hostile acts (See Israeli terror victims' compensation law – 1970). The organization maintains the largest information bank of victims among all other organizations in Israel.

Among us there are thousands of people who have lost their loved ones in split seconds, along with their ability to conduct normal lives, so we, as a society, believe that consequential traumas cannot be overlooked . Many suffer from trauma and anxiety, and without professional help will remain restless and vulnerable. The organization is committed to working for the welfare of victims, with the aim of guiding victims through their recovery. Various special needs of victims are addressed and an effort is made to improve their lives socially, economically, culturally and spiritually. The Organization aspires to provide its members with the necessary tools to transform their personal pain into constructive strength, using personal and spiritual growth that eventually will help them overcome their physical and emotional barriers. In doing so, we help in making their lives more meaningful and satisfying.

Organization's activities may include:

- Attending to personal issues of our members such as claims concerning local authorities and government offices, including presenting material and following up each individual case
- Maintaining a group life insurance plan for members of the organization

- Organizing day care and summer camps in Israel and abroad for the children of families that have been victimized by hostile acts. These activities allow the children to experience and enjoy vacation time and also to build new meaningful relationships with other youth.
- Organizing annual Bar-Mitzvahs for the children of the families victimized by hostile acts, including a day trip to Jerusalem

Larger budget will allow not only to expand operations but also give more casualties the professional assistance that allows dealing daily with the pain, trauma and longing.
